JET PARTS ENGINEERING ANNOUNCES FAA APPROVAL OF 22 NEW PMA PARTS

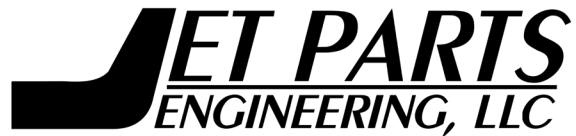
